#### Fair Deal



- Scheme Advisory Board discussion paper March 2015
- "Protected Transferee Employees/Employers"
- Higher and Further Education: Fair Deal disapplied
- Duties on Administering Authorities
- Re-tenders

## D Jones v Ealing Council (2015)



- Background legislation
- Mr Jones employed by Ealing until 2005
- TUPE Transfer to First Contractor: Continued LGPS membership
- TUPE Transfer Second Contractor: (April 2008)
  - Group self-invested personal pension arrangement
  - July 2008 Redundancy: immediate unreduced pension from LGPS
- Claim upheld against Ealing

## **Employer Contributions and Exit Debts**



- Rates and Adjustments Certificate: LGPS Regulations 2013; Regulation 62(1)(c)
- Exit Debts: Regulation 64:
  - Suspension notice up to 3 years to pay if exiting employer likely to re-employ active member(s)

# Thomas Ferens Academy v East Riding Council (2015)



- Academy established 2012
- Transfer agreement "Academy shall be responsible for any LGPS deficit ...
  referable to service up to and including the Transfer Date"
- Total contribution rate 43.4% (24.6% future, 18.8% past service)
- Reasonableness?
- Ultra vires?

#### The IORP Issue



- IORP Article 18 to be transposed into the Investment Regulations?
- The Unison 2007 Opinion: SSAB's further Opinion (September 2014)
- The issues:
  - Is there an ultimate guarantor for LGPS benefits and if so, who is it?
  - In whose interests must LGPS assets be invested?
  - What are the consequences of the LGPS funds being IORPs?
  - If IORP applies to the LGPS, does the law need to change at all?

#### **IORP II Directive: Where Are We Now?**



- Green paper June 2010 proposed revising IORP Directive 2003
- 'Solvency' was dropped from IORP II in May 2013
- March, September and November 2014: new proposals
- October 2014, EIOPA consultation on the 'Holistic Balance Sheet'
- May 2015 EIOPA stress-testing exercise published
- December 2015 results published
- March 2016 EIOPA advice to European Commission
- December 2016 in force?
