## **Save the Date!**

Save the date for the late autumn Local Authority Accounting Conference which has been provisionally booked in for 29 November and will take place online. The outcome of the summer code consultations will be confirmed and discussed, so make sure to keep the date in your diaries for these important Local Authority accounting updates.

## **Consultation of the 2023/24 Code of Practice**

The 2023/24 code of practice is due to go out for consultation this week. It will contain amendments to the following sections of the code:

- IAS 8 Accounting Policies, Changes in Accounting Estimates & Errors - Changes to the definition of accounting estimates
- IAS 1 Presentations of Financial Statements, and IFRS Practice Statement 2 - Making materiality judgements: disclosure of accounting policies
- IAS 12 Income Taxes - Deferred tax relating to assets & liabilities arising from a single transaction
- IFRS 3 Business Combinations - Reference to conceptual framework

It is extremely important that we have practitioner input into these changes so please do respond to the consultation and have your say on the proposed changes. We will send out the link as soon as the consultation becomes live. Watch this space!

## **Update Statement on Infrastructure Asset Reporting**

Thank you to everyone who responded to the consultation on infrastructure assets that closed on 14th June. On 27th July CIPFA LASAAC issued an update statement on the outcomes of its infrastructure asset reporting. You can view the update statement [here](#).

## **Voluntary Adoption of IFRS 16**

As you may be aware, following an emergency consultation, the mandatory adoption of IFRS16 for Local Authorities has been granted a 2 year deferral as an interim measure to help ease pressures from local audit. However, LASAAC have issued a statement recognising that IFRS16 represents the best accounting practice and is therefore encouraging all Scottish Local Authorities to implement IFRS16 as of 01 April 2022. You can find guidance for early adoption in appendix F of the 22/23 Code.

## **Draft Bulletin 11**

Draft bulletin 11 focuses on determining whether a mere/bare licence constitutes a lease under IFRS16. It will therefore only become applicable once IFRS16 is adopted by the local authority. We recommend that anyone planning early adoption of IFRS16 pay consideration to this bulletin when doing so, as this will be an important consideration.

The bulletin is currently due to go through the approval process of the Accounting & Financial Reporting Forum and CIPFA's Public Financial Management Board for issue; we will post further updates when they become available.

## **Consultation on Practice Note 10**

The Public Audit forum is consulting on the exposure draft for the 2022 revision of practice note 10: Audit of Financial Statements and Regularity of Public Sector Bodies in the United Kingdom (PN10) which is expected to be issued in Autumn 2022. The consultation draft has been approved by the Financial Reporting Council and Invitation to comment is open. Details of the consultation draft along with invitation to comment can be found on the [Public Forum Website](#). The deadline for responses to the consultation is Friday 16 September 2022.
