Deadline consultation for publication of unaudited accounts

On 16 February the Department for Levelling Up, Housing and Communities (DLUHC) issued a short consultation on the provisions of the Accounts and Audit Regulations 2015 (as amended) in respect of the publication date for the 2022/23 unaudited financial statements for category 1 authorities in England.

the department is keen to hear views from the sector and welcomes any <u>contributions via an</u> <u>online form.</u>

Practitioners are requested to include any unintended consequences or equalities impacts which you think are relevant.

All responses to the department should be submitted by 11:59pm on 2 March 2023.

In the meantime, DLUHC has stated it expects local authorities to continue to work towards the existing statutory deadline of 31 May.

Based on the discussions and feedback at our 2022/23 Accounts Closedown workshops, this is an important development for practitioners. As we anticipated, the timescale for this consultation is a short one, we encourage authorities to respond to this consultation with your views by the deadline of 2 March 2023.

CIPFA Code Guidance Notes

The Code of Practice on Local Authority Accounting in the United Kingdom: Guidance Notes for 2022/23 Accounts has been published and is now available on the CIPFA website. For those with a digital publication subscription or wanting to purchase a digital copy you can do so <u>here</u>. And for those wishing to purchase a hard copy those area available too <u>here</u>.

Following on from the publication of the Code Guidance Notes, an updated guide to IFRS 16 is due to be released also so watch this space!

The <u>disclosure checklist</u> and <u>Service Reporting Code of Practice</u> are also now available for pre-order with expected publication dates to be end of February, and March 2023 respectively.

Collection Fund Update

As we approach closedown, please be aware of the support CIPFA can offer to help with the Collection Fund. CIPFA produces <u>accounting models</u> that guide you step by step through compiling the NDR and council tax collection fund, the required journals and what the final outturn position, collection fund and general fund should look like. The NDR model also calculates the safety net or levy position and can be used by NDR pools to establish the pool benefit. CIPFA can also provide more direct help, either by supporting the production of your collection fund accounts or by reviewing the approach you have taken, providing reassurance and feedback to smooth the audit process and underpin financial estimates.

Public Financial Management Can Lead on Climate Action: The Case for Carbon Pricing

CIPFA have recently republished a report on the case for carbon pricing. By integrating climate considerations into performance measurement, reporting and spending decisions, public finance professionals can play an important role in advancing the global adoption of carbon pricing. By better aligning economic activity with the cost of environmental impact, carbon pricing can form an integral part of a whole system approach to a country's green transition.
