

# Eligibility for the direct route to CIPFA membership

- Professionally qualified accountant with five years or more post-qualification public sector experience.
- A member in good standing, with a recognised accountancy body e.g. ACCA, CIMA, ICAEW, ICAS and CAI.\*
- No studies or exams required just a simple online application form to complete.

#### Other routes to CIPFA membership

We also offer other routes to full and affiliate membership of CIPFA for those with less than five years' post-qualification experience, for AAT qualified professionals and for non-accountancy professionals working in public services who are not yet qualified accountants.\*\*
