4. Annual Report and Accounts for 2018

ANNUAL REPORT 2018

President's and Chairman's Report – Mike Thomas

Introduction

Well what a day to choose for our AGM – the day we leave the EU - or do we? At the time of writing this report we still don't appear to be any more certain than we were back in June 2016. Further votes continue to take place in House of Commons and the level of uncertainty in the public and private sector, financial markets and business confidence continue to fluctuate widely. It's been a fascinating time to be Regional President.

I can't believe it's been two years since I took over from Shaer and I remain hugely proud to have been chosen as Regional President and to have had the opportunity to serve the Region. I look forward to being a part of the regional Council in the future despite now working some distance away in a remote outpost of CIPFA in the Channel Islands with only 28 members – most of whom I have already met.

During my time as President the challenges facing the public sector have continued to increase with significant pressures in the health and social care system. We continue to see organisations coming together in a range of different structures to try and resolve the issues facing them and their communities with greater commercialisation in some areas but also organisations taking services back in house. We have seen the failure of some large companies providing a range of services to the public sector most notably Carillion and Interserve. We have had a major local authority having to issue a section 114 notice for the first time in over two decades. Thankfully not in the North West but a timely reminder of the need for strong financial planning and management during these difficult times. It is worth noting that a former North West member Ian Duncan has stepped in to try and turn the ship around in Northamptonshire.

Regional Conference and Dinner

But it's not all bad news as we saw at our Regional Conference in September. The meeting showcased some of the most innovative solutions and discussed some of the future challenges. There were many reasons to be positive, whether it was from the Culture Team in Liverpool who outlined how they have used a very commercial approach to using the city's cultural assets to help with economic development and regeneration; to the work being undertaken at the innovation unit at Alder Hey Children's hospital; to the presentation from Axon regarding managing people in challenging times; or from Crown Commercial Solutions on how to deliver effective procurement solutions; or to the unforgettable presentation by Clare Lomas who outlined her life story and the significant challenges she has faced in adversity following a horse riding accident. A huge thanks must go to my Vice President Stephanie Donaldson who arrange for Clare to speak to us and to Mazars who provided the valuable sponsorship. We are increasingly grateful to our sponsors Zurich and Axon, as well as to all those other companies that have sponsored the Council and our sub-groups. The financial challenges facing the sector are also being felt by CIPFA and we continue to look for ways to work with CIPFA centrally and within the region to look at cost effective ways of delivering events and professional development for members.

Recurring issues during the last year, both within the region and the profession generally, have been ethics and resilience. Members of the Council and sub-groups have been involved in leading events on ethics and I was proud to do a joint presentation on ethical issues to the Audit group in September. Most of our groups continue to go from strength to strength particularly the Audit Sub Group, Retired Members, Northern and the Students Groups. We remain committed to re-vitalising the Southern Group and Senior Mangers Groups.

Finally, it would be remiss of me not to mention the Students group's nomination at the PQ awards at the event at the CAFÉ de Paris - being nominated and robbed again. But as with many events the NW team celebrated in an appropriate manner taking advantage of the two for one cocktails.



Sub-Group reports

The activity going on within the sub-groups is fantastic as all groups are really proactive and host a diverse range of seminars, training and social events to support members and students across the region:

(a) AUDIT, RISK & GOVERNANCE GROUP – Chair, Mat Tanner

My first year as Chair of the group has flown by and I'd like to thank all group members for their continued support throughout the year. It has been a strange time for me to be in the Chair role as I have been on secondment in finance within the NHS for most of the year, but it has been rewarding and it has broadened my experience and given me a better understanding of the health & social care integration agenda.

Group Membership & Strategy

Broadening of work roles is a trend that is continuing apace as integration moves forward and organisations rationalise workforces, and it was these increased commitments at work that unfortunately saw Cath Fogarty stepping down after 22 years as an active and very valued member of the group. I sent Cath a message of thanks for her work and friendship over the years on behalf of the group.

Various group members have been a real support during the year and I'd like to thank Lesley as vice chair for her advice and attending NW Council meetings when I couldn't make them, Sarah for her hard work in her role as treasurer, and to Jean, Janet and Stewart for their guidance and encouragement.

I'd also like to give a mention to Judith as she continues to be instrumental in making sure that the group's events run as smoothly as they do, and being the calm and professional face of the group to delegates on the day.

Activities & Events

Last year's annual training event was once again at the Low Wood Hotel in the Lake District (but it may be the last one there for a while due to the cost!), delegate numbers were reduced slightly, mainly due to the Beast from the East, but feedback was very positive as always.

The Autumn Seminar in 2018 was held at the new conference facilities at County Hall in Preston which proved to be very popular with those in attendance. Numbers were down on previous years, with 75 delegates, but this proved to be a blessing in disguise as the room wasn't as big as we thought, and a healthy surplus was made due to the low cost of the facilities. Jean worked tirelessly this year to ensure there was a full programme of speakers, and once again there was a focus on counter fraud for part of the day, with topics including fraud against charities, an update on the CIPFA counter fraud hubs, an overview of the work of the GMP Economic Crime Unit, and cyber fraud risks.

A GDPR practical workshop was held in central Manchester in November, facilitated by John Pearsall and Tom Powell and was very successful with delegates sharing experiences and best practice following GDPR's introduction in May 2018.

A follow up workshop on Direct Payments audit and counter fraud was planned for this year but has been moved back to April 2019 and will be held at County Hall in Preston, again being facilitated by Lynn Anders and Simon Bleckly.

CIPFA Regional and National Events

The group have continued to work with the NW region to provide support, and we have attended all but one of the NW Council meetings during the year. The group had representatives at the NW annual dinner in September in Chester and in July I attended the national CIPFA conference in Bournemouth where I was able to link with the South West regional group and help out on the CIPFA regions stand there.

Conclusion

I would like to thank every member of the group for your contributions this year. Whether it is organising or facilitating an event, contributing ideas, or supporting other group members, the enthusiasm of members and commitment to the group's aims is what ensures that our programme of events continues to offer value for money and attract delegates.

(d) NORTH WEST CIPFA STUDENT NETWORK - Naomi Jackson, Acting Student President

Building on from an excellent year in 2017/18 the NW:CSN has had another successful year and have continued to build our profile with students through events and increased social media presence. Instagram has been our fastest growing platform this year and we are followed by Liverpool University, Cumbria University, and Tameside Council.

We were pleased to be chosen as one of five student groups from both the public and private sectors to be shortlisted for PQ Magazine's 'Student Body of the Year Award' at the PQ Awards 2019. This is the third consecutive year that we have had the opportunity to attend the awards ceremony at Café de Paris where we joined with CIPFA colleagues in London, and engaged with the accounting department of Manchester Metropolitan University. Hassan Khan, who has volunteered on the network for four years, was also shortlisted for 'Newly Qualified Accountant of the Year' – a highly commendable achievement.

With only eight volunteers this year, it has generally been a year for background planning, assisting the NW Council in its regional development plan, and building new contacts. The majority of our budget this year was used in supporting 20 students to attend the North West Summer Seminar in Chester. Volunteers have attended and contributed to NHS Development Days, Careers Insights at Liverpool University, and Manchester University's Graduate Fair.

NW:CSN were pleased to be able to facilitate a session with CEO Rob Whiteman after we raised concerns about examination delivery. This was co-ordinated with student support and highlighted the need for roadshows around the country to discuss training, apprenticeships, portfolios, and all other relevant CIPFA developments.

In January, we held an Intermediate level Microsoft Excel course to allow CIPFA students to enhance necessary skills for the workplace. This was delivered by the Learning and Development Team at Liverpool City Council and was extremely well received with a strong desire to hold a similar event in the future.

We continue to run our own Strategic Level revision in each exam sitting bringing students together to share ideas, real world knowledge, and tackle issues prior to exam period. Feedback from this has proved that having a newly qualified volunteer to facilitate the session is extremely useful.

I would like to thank the North-West Society Council for its continued support of the NW CSN in our activities. I would also like to say a huge thank you to all the students who give up their time to volunteer with the NW CSN, despite balancing full time work with a demanding qualification, they continue to give up their limited free time to ensure that other CIPFA Students can access additional support and the opportunity to develop their skills and networks. These events would not be possible without all their hard work. I would like to wish the new executive the best of luck and whilst I have really enjoyed being president I am pleased to be handing over to such a dedicated and capable individual, in Sophie Darlington, who I know will do an excellent job in the coming year.

The Retired Members' Group continued to go from strength to strength in 2018 with membership at each event averaging 24, with overall attendance of some 30+ active members.

We began the year with our Spring event in April – a private tour of Manchester Police Museum followed by lunch at Cote brasserie off Deansgate. Our guide at the museum was a retired Policemen who was full of tales of the inmates of the police station, the gangs of the 1950s and the history of the Chief Constables of Manchester. We all felt that we could have spent much more time there as he was so full of fascinating tales. This event was notable as two members who worked in the North West but currently live near Doncaster joined us. We're getting a reputation for good events!

The Autumn meeting took place in September in Chester. We organised a special private boat trip with guided commentary along the river Dee. Although the weather could have been better it didn't prevent us from having a really good day. We saw and heard about the history of Heronbridge and Eccleston Ferry, with its Grade II listed ferry house. The river meanders through some spectacular scenery and there were opportunities to spot plenty of wildlife. The boat trip was followed by a 2/3 course lunch at Chez Jules, a long-standing Chester restaurant. We had a room to ourselves and all agreed it was one of the best, if not the best lunch so far.

The Christmas event was held in Salford where the Group had a private tour of the BBC studios at Media City followed by Christmas Lunch at the Alchemist. For the first time in the existence of the group, the tour was fully subscribed with 24 participants before a letter to all members had even been written. We had announced the plan at our previous event in Chester and all spaces were taken up prior to full details being confirmed. There was even a waiting list and so I think that is a reflection of how well the group is working.

Our two guides were knowledgeable and enthusiastic about the both the history of the site and the various studios we went into, the first being a radio studio. ANNUAL STATEMENT OF ACCOUNTS

Honorary Treasurer's Report

Consolidated CIPFA North West financial position as at 31 December 2018 had a positive net movement in funds of £7,640 and positive fund balance carried forward of £74,551.

CIPFA North West accounts contain following sections:

- CIPFA North West Council
- Audit Risk and Governance Group
- Northern Section
- Southern Section
- North West CIPFA Student Network

The surplus balance achieved in a year is mainly due to sponsorships and well attended regional events that have resulted in positive balances.

Region's reserves are split into restricted and usable reserves. Restricted reserves are funds to be used for educating and training students. This reserve will continue to be utilised in 2019 to ensure that the CIPFA North West students across the region benefit from additional educational support and training courses.

General fund balances represent sufficient sum to meet short term cash requirements when organising events and settling expenses. CIPFA North West has seen a reduction in subvention from CIPFA so it is more than ever important to ensure that adequate cash balances are held in the bank to meet any immediate requirements for substantial funds for regional events.

Treasurer would like to express appreciation for the assistance in account preparation to Sarah Oldendorp and Martin Wren. Support from Jen Bevan was also appreciated.

I would like to wish the best of luck to my successor as this is my last report as a Treasurer for the CIPFA North West. I truly enjoyed this post and would like to wish the Society all the best for the future and good luck to Stephanie and Andrew as they will guide the CIPFA North West in the upcoming years. I hope I will be able to rejoin the Society soon.

HONORARY TREASURER'S REPORT

Consolidated CIPFA North West financial position as at 31 December 2018 had a positive net movement in funds of £7,640 and positive fund balance carried forward of £74,551.

CIPFA North West accounts contain following sections:

- Audit Risk and Governance Group
- Northern Section
- Southern Section
- North West CIPFA Student Network

The surplus balance achieved in a year is mainly due to sponsorships and well attended regional events that have resulted in positive balances.

Region's reserves are split into restricted and usable reserves. Restricted reserves are funds to be used for educating and training students. This reserve will continue to be utilised in 2019 to ensure that the CIPFA North West students across the region benefit from additional educational support and training courses.

General fund balances represent sufficient sum to meet short term cash requirements when organising events and settling expenses. CIPFA North West has seen a reduction in subvention from CIPFA so it is more than ever important to ensure that adequate cash balances are held in the bank to meet any immediate requirements for substantial funds for regional events.

Treasurer would like to express appreciation for the assistance in account preparation to Sarah Oldendorp and Martin Wren. Support from Jen Bevan was also appreciated.

I would like to wish the best of luck to my successor as this is my last report as a Treasurer for the CIPFA North West. I truly enjoyed this post and would like to wish the Society all the best for the future and good luck to Stephanie and Andrew as they will guide the CIPFA North West in the upcoming years. I hope I will be able to rejoin the Society soon.
