RDP was reviewed and Council agreed:

- need to be clear to CIPFA about the impact of the reduction in subvention.
- to split Section 4 of the RDP (Development Funding) into Core Funding and Development Funding.
- no in year variations are required but will revisit at a future meeting

2023 budget was reviewed. Hope to have future subvention clarification at the Autumn Forum but that is yet to be confirmed. CIPFA have not provided a clear view on the level that our reserves should be at. Council agreed:

- to change the wording of 'paid support' to 'future paid support'
- reduce one off handover costs line from £10k to £5k.
