Regional Development Plan 2023 (RDP23) had been amended and resubmitted on 14 February in response to the invitation from CIPFA following the 24 January subvention notification of £18,920 (£16,920 development funding plus £2,000 basic subvention) for 2023. As no response had been received from CIPFA in respect of the resubmitted RDP23, Council agreed a 2023 Budget (per Paper SEO2305 but with a £5k reduction to line 18 and which is to be added to line 49 but the new total of £10k is not yet approved). CIPFA will be chased for a response to the resubmitted RDP23 and the result will be reported to Council. Consequently, the 2023 Budget may need to be further reviewed.
- 7. Regional AGM 27 April 2023.
 - The agenda draft was agreed. Council agreed nominations for the elective 2023/4 Officer roles shown in italics (subject to no further nominations being received by 28 March) and the vacant Council membership positions. Co-optee requirements will be further considered at May Council to ensure there is adequate representation from around our region and sectors.
 - KL and NC reported on progress for their reports and expected audit completion after some minor adjustments to the draft accounts.
