4. Regional Development Plan and Budget 2023.

The Plan was submitted in October 2022 and a subvention of £18,920 was notified on 24 January 2023, calculated to be applied to a range of activities in the year. It did not agree any potential costs during this year for succession planning. Following representations to CIPFA a revised bid was submitted for review during February. Accordingly, Nicki advised at 21 March Council that we set our 2023 Budget based on the £18,920 subvention and revise it if any further subvention was agreed. An additional subvention of £3,000 is now

agreed by CIPFA but has not been allocated to detailed budget lines - so should be regarded as a contingency at present.
