## **January 2022** **Preparing the Pension Fund Workshops**

This virtual learning event is aimed at pension fund accountants. It uses a line-by-line approach, deconstructing the Fund Account and Net Asset Statement to give learners a comprehensive understanding of financial reporting requirements for local government pension schemes.



## **February 2022** **Audit and Accounting workshops**

In recent years the pension fund accounts have reached a high standard driven by increased scrutiny and the support of the CIPFA Example Accounts. Naturally this will lead to a discussion on the work of external audit, and we will hear our usual feedback on the 2020/21 audits and what the key issues will be for 2021/22.
